## EXPLANATORY NOTES

A transcript is issued to students at the end of each study level. If a student has completed his/her studies, the transcript will include details of any award made.

### Credits and Levels

Undergraduate programmes of study normally consist of modules totalling 120 credits for each study level. Since 1998, postgraduate programmes of study normally consist of modules totalling 180 credits.

Level 0 is normally equivalent to the foundation year of an undergraduate degree programme. Levels 1, 2 and 3 are normally equivalent to the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> years of a full-time undergraduate degree. For students following other modes of study, there will not always be an equivalence between level and year of course.

Level 5 represents work normally associated with Master's level.

Level H represents study on programmes leading to Higher National awards.

Level F represents study on programmes offered by the Rambert School of Ballet and Contemporary Dance.

### Teacher Training Agency Basic Skills Tests

On successful completion of their programme of study and ED9999, students studying courses in Education are recommended to the General Teaching Council (GTC) for Qualified Teacher Status (QTS). A grade of "I" against ED9999 indicates that the student has not yet completed all three (numeracy, literacy and ICT) of the Basic Skills Tests.

### Valid Classifications

First Class Honours (1)	70% - 100%
Second Class (Upper Division) Honours (2.1)	60% - 69%
Second Class (Lower Division) Honours (2.2)	50% - 59%
Third Class Honours (3)	40% - 49%

A student who has narrowly failed to reach the standard for an Honours degree may be awarded a Pass degree.

A student awarded an Ordinary degree will have followed a course of study with different aims and objectives, number, credit, value and levels of modules, from an Honours degree.

A student may be awarded an Aegrotat degree where, for good reason, they have been unable to complete the normal requirements for the degree but have provided the evidence that they would otherwise have obtained the award.

Taught postgraduate courses are not normally classified.

A distinction may be awarded on some undergraduate and postgraduate taught courses.

### Exemptions

Students may be exempt from certain modules or from one or more study levels on the basis of previous experience or learning.

### Sandwich Courses

Students following sandwich courses will normally have undertaken one or more periods of workplace experience totalling at least 44 weeks, during their programme of study. Further details of the workplace experience are available from the University.

### Date of Award

The date of the award, where applicable, is the date of the appropriate Examination Board's recommendation to the University Senate. The date printed on the certificate normally differs from that shown as the date of award on the transcript.

### Validation

The transcript is not valid without the validating stamp and the signature of the Head of Department/School or his/her nominee. An example of the validating stamp is shown below:
