



Regulations for the processing of personal data of participants of the program International Alumni UMCS

1. The administrator of personal data of participants of the International Alumni UMCS program is the Maria Curie-Skłodowska University in Lublin, based in Lublin (20-031), Pl. M. Curie-Skłodowskiej 5, NIP 712-010-36-92, REGON 000001353 (hereinafter referred to as the University or UMCS).
2. The data will be processed by the University:
 - a. in terms of name, surname, e-mail address, description of interests, Polish / English language, location, country and town - pursuant **to art. 6 clause 1 letter b)** of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (the so-called General Data Protection Regulation / **GDPR**), for the entire period of use of the Alumni @ UMCS application
 - b. to the extent other than the above. indicated, among others photos, phone number, links to social profiles - based on art. 6 clause 1 lit.
 - c. pursuant to **art. 6 clause 1 lit. f) GDPR** as regards determination, investigation and protection against possible claims for the period required by law to secure claims (6 years).
3. The Personal Data Administrator informs that in the case of data processing based on consent, pursuant to art. 7 clause 3 of the General Regulation on the Protection of Personal Data, the data subject has the right to withdraw consent at any time (using the tool available at: <https://apps.umcs.pl/apps/>) and that the withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal. In addition, in accordance with art. 15-21 and art. 77 of the General Data Protection Regulation, the data subject has the right to access, change, rectify, delete or limit processing, the right to object to data processing and to lodge a complaint with the supervisory authority, as well as the right to transfer data.
4. The data is collected by the University solely for the purpose of launching and supplying the Alumni @ UMCS application and will be processed only for the purposes indicated above. They will not be subject to further processing or profiling, nor will they be based on



automated decisions. They will not be sold or made available to external entities, except for entities and circumstances of their disclosure provided for by law

5. Providing data is voluntary, but necessary to use the Alumni @ UMCS application.
6. In the Alumni @ UMCS application visible will be only the content that the person joining the Alumni @ UMCS program will choose to be shared. Information about yourself (such as name, surname, e-mail, description of interests, city and country of residence and possibly a photo, phone number, links to social profiles) provided voluntarily by a participant of the International Alumni UMCS program will be publicly available in the mobile application and visible to users Alumni @ UMCS application. Only people using the Alumni @ UMCS application will have access to the information provided and will be able to contact UMCS Ambassadors from the International Alumni UMCS program.
7. Personal data of UMCS International Alumni program members are secured against unauthorized disclosure to unauthorized persons, unauthorized access, removal, damage, modification or accidental destruction or loss.
8. Please be advised that when providing the service: the Alumni @ UMCS mobile application, the University does not access the User's data on the device or allow it to third parties. User traffic in the application is monitored by the GoogleAnalytics service.

9. The Maria Curie-Skłodowska University has appointed a Personal Data Protection Inspector, who in case of any problems or doubts in the area related to data processing at UMCS, can be contacted at the following e-mail address: dane.osobowe@poczta.umcs.lublin.pl .

Information about cookies
