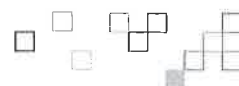

**Classes' organisation during winter semester at Faculty of Political Science and Journalism
of Maria Curie-Skłodowska University in Lublin, academic year 2020/2021**

Acting in accordance with Maria Curie-Skłodowska University in Lublin's Rector's Ordinance of 20 August 2020 concerning *classes' organisation during winter semester of academic year 2020/2021*, classes at Faculty of Political Science and Journalism will be undertaken in a hybrid form.

1. Regarding full-time studies of *Bezpieczeństwo Narodowe, Dziennikarstwo i Komunikacja Społeczna, International Relations, Politologia, Produkcja Medialna, Public Relations i Zarządzanie Informacją, Społeczeństwo Informacyjne, Stosunki Międzynarodowe*, year I, BA level, classes are recommended to be undertaken in a stationary form in the Faculty's new building at Głęboka 44. Classes may still be undertaken in an online form under following circumstances:
 - a) too large amount of students and lack of sufficient room to submit to current safety measures,
 - b) a lecturer reporting such need under consideration of being in a higher risk group,
 - c) any other exceptional cases, approved by the Dean.
2. Regarding full-time studies of *Bezpieczeństwo Narodowe, Dziennikarstwo i Komunikacja Społeczna, International Relations, Politologia, Produkcja Medialna, Społeczeństwo Informacyjne, Stosunki Międzynarodowe*, year 2 & 3, BA level & *Administracja Publiczna, Bezpieczeństwo Narodowe, Dziennikarstwo i Komunikacja Społeczna, International Relations, Politologia, Produkcja Medialna, Społeczeństwo Informacyjne, Stosunki*



Międzynarodowe, year 1 & 2, MA level, classes are recommended to be undertaken in an online form. Classes may still be undertaken in a stationary form under following circumstances:

- a) for classes to be effectively undertaken, there is a need for specialistic hardware or software,
 - b) any specific form of classes (e.g. seminars, lab classes etc.) and availability of sufficient room allowing submission to current safety measures,
 - c) any other exceptional cases, approved by the Dean.
3. Regarding doctoral studies (year 3 & 4), classes are recommended to be undertaken in a stationary form. Classes may still be undertaken in an online form under following circumstances:
- a) a lecturer reporting such need under consideration of being in a higher risk group,
 - b) any other exceptional cases, approved by the Dean.
4. Office hours & consultations are being realized on the set dates in both stationary and online form. Lecturers are to notify about dates and preferred form via noticeboard on the Faculty's webpage and their profiles on the University's webpage no longer than a week after the beginning of the winter semester.
