Definition	The measure includes receiving an award for artistic activities of international importance. The nature of the award: individual or collective. The awards granted by a renowned artistic or cultural centre, international organisations or other prestigious institutions.

Data provided	Name of the award, subject of the award (e.g. specific work, scientific achievement), awarding institution/body, awarding country (if applicable), type of awarded activity, winner/winners (in case of a collective award)

Definition	The measure covers the number and duration of stays of foreign academics at different levels, conducting research and teaching activities at UMCS. The measure covers employment: 1) min. 3 months in case of conducting research 2) min. 60 h of classes and the title of professor or associate professor if the employed person(s) conduct(s) only teaching activities. Any form of employment possible: civil law contracts or employment contracts, including those sponsored by foreign institutions, also embassies, e.g. within the framework of Erasmus+, Kirkland, Fulbright and other programmes.

Objective	Wider dissemination of research and strengthening the image of UMCS abroad
Definition	The measure is calculated for each scientific discipline evaluated at the University in accordance with the list of disciplines; it is as a quotient of the number of publications in foreign journals from the ministerial list published in a given year divided by the N number (at the year end), i.e. $W_{lp} = \frac{LPOM}{N}$ , Where: LPOM - the number of publications in foreign journals from the ministerial list, which were published with the date of a given year in the final form (NOTE: this includes articles published in Polish journals published in a language other than Polish, provided that the journal is on the ministerial list) N - the number of members of staff counted as N at the end of the year in a given discipline

The contracts may, among others, relate to:</li> <li>paid research services, analyses, expert opinions</li> <li>commercialisation (licensing or sale) of research results</li> <li>involvement in scientific and industrial consortia.</li> </ul>
