## UMCS World Games event regulations

### I. Organizer

The organizer of the "UMCS World Games" event is:

Maria Curie-Skłodowska University in Lublin

in cooperation with the University Board of the Student Self-Government of UMCS

hereinafter referred to as the "Organizer"

### II. Date and place of the event

The event will take place on May 14-15, 2021 at the following venues:

1. Basketball - a multi-purpose sports field of the CKF UMCS
2. Football - Orlik, Primary School No. 6, ul. Czwartaków 11 (?) / Multi-purpose sports field CKF UMCS
3. Beach volleyball - CKF UMCS beach volleyball court
4. Tennis - CKF UMCS tennis courts

### III. The nature of the event

1. During UMCS World Games, i.e. May 14-15, 2021, 4 sports disciplines will be played: basketball, football, beach volleyball and tennis, during which the best teams consisting of foreign students undertaking education in the academic year will be selected 2020/2021 at Lublin universities.
2. The event is financed by the Polish National Agency for Academic Exchange as part of the project entitled "Welcome to UMCS - an integrated set of activities and institutional improvements aimed at strengthening the efficiency of UMCS in the field of student and



doctoral students and staff from abroad "AGREEMENT NO: PPI / WTP / 2019/1/00058 / U / 00001 as part of the Welcome to Poland program.

#### **IV. Purpose of the event**

1. Promoting physical activity as a form of spending free time,
2. Organization of a sports event encouraging a healthy lifestyle and active recreation
  1. and recreation,
  2. Sports competition in the spirit of fair play,
  3. The combination of sports competition with fun, recreation and relaxation,
  4. Integration of students from Poland and foreign students undertaking studies at Lublin's universities,
  5. Popularization of basketball, football, beach volleyball and tennis.

#### **V. Participation**

1. The event is open to foreign and Polish students who study at Lublin universities in the academic year 2020/2021 (individual disciplines: tennis) and teams consisting of the above-mentioned people (team disciplines: basketball, football, Beach volleyball).
2. **People from Poland cannot constitute more than 1/3 of the statutory number of people in a given discipline - football and basketball. In beach volleyball**
3. **a team may enter a maximum of 1 person from Poland. In tennis, people from Poland may constitute 1/3 of all registered people.**
4. Point 2 is subject to point VII.3.



5. During verification at the competition office, each participant should present a document confirming education at one of the universities in Lublin.
6. Competitors are required to wear accreditations, which will be issued during verification at the competition office.
7. In order to register a team, fill in the recruitment form on the UMCS website (link: <https://www.umcs.pl/pl/world-games-umcs,18754.htm>)
8. In the event of a large number of applications, the Organizer reserves the right not to accept all the submitted persons / teams. In such a case, the information will be provided by e-mail.

## **VI. Disciplines**

### **1. Basketball**

A team may enter the competition, which will include any number of women and men, but the entire team may not exceed 4 people. During the match, there may be 3 players from a given team on the field and 1 person as a substitute. The composition of the team remains the same throughout the competition.

The regular playing time is 15 minutes, with no stopping time. However, the team that scores 21 points or more during regular game time wins the match before the time runs out. If the score remains tied at the end of regular time, extra time will be played. The first team to score 2 points in extra time wins the match.

Time will only stop when a team time-out is given. The team is entitled to one 1-minute break.

### **2. Football**

A team may enter the competition, which will include any number of women and men, but the entire team may not exceed 9 people. During the match, 6 players from a given team and 3 substitutes may be on the pitch. The composition of the team remains the same throughout the competition.



The match will be played in the formula of 2 x 20 minutes, with no stopping time.

### **3. Beach volleyball**

A team may enter the competition, which will consist of a maximum of 2 people without gender division (2 women / 2 men / 1 woman + 1 man). The composition of the team remains the same throughout the competition. The match will be played in the formula for 2 sets won, up to 11 points, with the two-point advantage of either team.

### **4. Tennis**

The competition will be played individually. Any number of women and men can take part in the competition. If a small number of people register, the matches will be played without division into gender. The duel continues until the first set is won. With a score of 5: 5, the game goes down to two games of advantage (7: 5 or 5: 7). In case of state 6: 6 - a tie-break (up to 7 points) is played.

## **VII Classification:**

1. Based on the results of the matches played, the final classification in a given discipline will be established.
2. If several participants are classified in the same positions, ex aequo places are awarded.
3. The following points are awarded in individual disciplines:
  - a. Basketball - 2 points - won the match, 1 point. - Lost Game
  - b. Football - 3 points - match won, 2 points - draw, 1 point - lost match
  - c. Beach volleyball - 3 points - won the match 2: 0, 2 points - lost the match 1: 2, 1 point - lost the match 0: 2
  - d. Tennis - 2 points - match won, 1 point – match lost

### **IX. The schedule of the event**

Schedule of events will be published immediately before the start of the competition on the website and social media events organizer.

### **X. Final Provisions**

1. During the entire event, the Organizer provides medical care for all participants.
2. The organizer is not responsible for lost items.
3. The organizer has the option to change the regulations until the competition in a given discipline starts.
4. The interpretation of these regulations depends solely on the Organizer.
5. Participation in the Event confirms that you have read these regulations.
6. The main coordinator of the competition is the Maria Curie-Skłodowska University in Lublin together with the University Board of the UMCS Students' Self-Government.

### **XI. GDPR provisions**

1. The administrator of personal data is the Maria Curie-Skłodowska University in Lublin, pl. Marii Curie-Skłodowskiej 5, 20-032 Lublin. Personal data is processed in accordance with the rules provided for in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data



and on the free movement of such data and the repeal of Directive 95/46 / EC (general regulation on data protection) and the Act of 10 May 2018 on the protection of personal data (Journal of Laws 2018, item 1000).

2. Personal data is processed for the proper organization of the "UMCS World Games" event. Personal data may also be processed for information and marketing purposes, provided that the User agrees. This consent may be revoked at any time.
3. The participant has the right to access his personal data, the right to correct, supplement, update, rectify or transfer data, as well as the right to request deletion of personal data (the right to be forgotten), and at any time to object to their processing. In order to exercise the above-mentioned rights, the Participant is obliged to submit an appropriate application by e-mail to the address [Promocja@umcs.pl](mailto:Promocja@umcs.pl)
4. Personal data is stored for the period of:
  - a. In order to properly organize the event "UMCS World Games" - until the end of the event or until the Participant submits an objection.
  - b. For information and marketing purposes, based on the consent given by the Participant - until the consent is withdrawn.
5. The Organizer does not disclose the processed personal data to any entity without the express consent of the Participant, unless the necessity to disclose it results from a legal provision or a decision of an authorized body. The club does not transfer processed personal data outside the European Economic Area.
6. The participant has the right to lodge a complaint with the President of the Personal Data Protection Office

**STATEMENT COVID-19**

I, the undersigned (s) in connection with the desire to participate in the event UMTS World Games, given the ongoing epidemic status in Poland, declare as follows::

- I am a healthy person with no symptoms suggesting the presence of an infectious disease, including in particular COVID-19 disease caused by the SARSCoV-2 coronavirus,

- I undertake to ensure on my own and to use personal protective equipment in accordance with the applicable guidelines, hand disinfection, comply with the rules established by the organizer and take care of myself and other participants of the competition,
- I undertake to immediately inform the organizers of any disease symptoms suggesting an infectious disease and submit to all decisions resulting therefrom - including withdrawal from competition.
