#### § 1 [Introduction]

- 1. **Maria Curie-Skłodowska University** in Lublin is conducting a project entitled "Preserving fundamental rights in the use of digital technologies for e-health services"- REINITIALISE. The project is funded by the European Union within the Horizon 2020 Framework Programme under grant agreement no. 952357. Project implementation period: from 01.01.2021 to 31.12.2023. **Project website:** www.reinitialise.eu/
- 2. The overall objective of REINITIALISE is to strengthen scientific excellence and innovation capacity at Maria Curie- Skłodowska University (UMCS), Poland, in the field of preservation of fundamental rights in the design and use of digital technologies and digital communication for e-health services, with a specific focus on a) health-oriented technologies for active ageing, and b) prevention care in the sectors of nutrition and dietetics.
- 3. The project is based on mutual exchange, knowledge transfer and interdisciplinary cooperation between UMCS and three leading institutions: **Catholic University of Leuven- KUL** (Belgium), the **University of Macerata- UNIMC** (Italy) and **Eurocentro- EUC** (Italy).
- 4. Within the project workplan, task 1.4 *Boosting international opportunities for ESRs from Uni- Lublin* foresees a 60-day fellowship to one of the following Universities:
  - KUL, Belgium: www.kuleuven.be/english: 4 Fellows
  - UNIMC: www.unimc.it/en: 4 Fellows

to conduct research described in one-page proposal with project idea\* under the supervision of the Host Institution and UMCS.

As a part of the fellowship, the Fellows will carry out research on specific research topics previously identified by the Partners in the previous tasks of REINITIALISE project: Task 1.2 - Mobility programme of senior researchers and Task 1.3 - Joint scientific workshops, under the guidance of specialists from Host Institutions. As part of the collaboration, the Fellow will be required to prepare 1 paper co-authored by researchers from Host Institutions. This work will be presented at prestigious conferences or submitted as articles in international journals. The ESRs will benefit from joint supervision during the fellowship: by a supervisor from the UMCS and by a supervisor from the host institution.

These call concerns the recruitment rules for the fellowship program at the partner institutions of the REINITIALISE project: KULeuven and University of Macerata.

**KU Leuven (KUL)** is a research-intensive, internationally oriented university with a strongly interand multidisciplinary focus. Several international surveys rank KU Leuven among the top ten European universities and among the top 80 in the world, taken into account the number of publications and citations and research funding and expenditure. KU Leuven is dedicated to education and research in nearly all fields. Its fifteen faculties offer education, while research activities are organized by the departments and research groups. All faculties and departments are clustered into three groups: Humanities and Social Sciences, Science, Engineering and Technology (SET), and Biomedical Sciences. The departments that will be involved in REINITIALISE with the aim of arranging transfer of knowledge to UMCS with regard to their key expertise and experiences, are:

- The Department of Electrical Engineering (ESAT) conducts research at a high international level and is responsible for education in the domains of electrical engineering, electronics, and information processing.
  - o Research group **e-Media Research Lab** belonging to the Faculty of Engineering Technology, investigates, develops and implements novel techniques to enhance the human condition with embodied media.
- The Department of Movement Sciences focuses on the themes of Health & Well-being and the optimization of health and well-being in society through motor and physical activities.
- **The Department of Neuroscience** focuses on the study of the biological stress response and autonomous nervous system in psychiatric disorders such as major depression, chronic fatigue syndrome and eating disorders.
- The Centre for Ethics, Social and Political Philosophy which is itself organized by three key axes: critical political theory, normative political philosophy (justice), and ethics.

University of Macerata (UNIMC) is one of the oldest HEI in Italy and only University in Italy which has a focus entirely on humanities and socio-economic sciences (SSH). University's motto "Humanism that innovates" illustrates its mission: to contribute to the development of people and society through the added value that social and human sciences bring to the understanding of complex socioeconomic and political issues, according to an interdisciplinary perspective. The departments that will be involved in REINITIALISE with the aim of arranging transfer of knowledge to UMCS with regard to their key expertise and experiences, are:

- The Department of Political Science, Communication and International Relations which main expertise include range from economics to sociology, from law to philosophy, from marketing to advertising, from public relations to communication, with a major emphasis on digital and media cultures.
- **The Department of Economics and Law** as evoked by its name, is a highly interdisciplinary department, including researchers from economics, business administration, law, mathematics and statistics, sociology and social science.
- The Department of Education, Cultural Heritage and Tourism which representatives in the project investigates on the valorization of regional enogastronomy distinctions and its role within the innovation process, and the promotion of healthy behavior connected with food and diets.

### § 2 [Conditions of the mobility programme]

- 1. Mobility programme consists of a **60-day fellowship** to one of the following Universities:
- -KUL, Belgium: www.kuleuven.be/english: 4 Fellows
- UNIMC: www.unimc.it/en: 4 Fellows

- 2. 8 Early Stage Researchers\* from UMCS can be selected to the programme.
- 3. Mobility programme may start from **must end by 15 November 2022**. The exact dates will be settled by the Fellow and Supervisor from KUL/UNIMC based on availability of both sides and COVID-19 restrictions.
- 4. The Fellow will conduct the research planned in the one-page proposal (see § 4, point 6). As a part of the fellowship, the Fellows will carry out research on specific research topics previously identified by the Partners in the previous tasks of REINITIALISE project: Task 1.2 Mobility programme of senior researchers and Task 1.3 Joint scientific workshops, under the guidance of specialists from Host Institutions. As part of the collaboration, the Fellow will be required to prepare 1 paper co-authored by researchers from Host Institutions. This work will be presented at prestigious conferences or submitted as articles in international journals.
  - 5. The ESRs will benefit from joint supervision during the fellowship: by a supervisor from the UMCS and by a supervisor from the host institution. Further mentoring will be carried out by supervisors from Host Institutions and UMCS through the Knowledge Platform (www.reinitialise.eu/kp/).
  - 6. After coming back to UMCS, Fellows **are obliged to conduct at least 2 lectures** for other Early Stage Researchers from UMCS, during which their experiences gained at partner universities will be presented.
- \* Young Researcher/Early Stage Researcher an early stage researcher who at the time of recruitment by the host organisation is within the first four years (full-time equivalent) of their research career and has not obtained a doctoral degree yet. Full-time research experience is measured from the date on which the researcher obtained the degree entitling him/her to undertake doctoral studies (in the country where the degree was obtained or in the country where the researcher was recruited), even if the doctoral studies were never started or planned. Part-time research experience is counted proportionally.

## § 3 [Conditions of participation in the programme]

- 1. The target group of the Programme consists of 8 Early Stage Researchers whose:
- research interests and work cover at least one of three cross-cutting interdisciplinary topics which are:
  - T1: an inquiry and mapping of the ethical and legal principles that might steer the design of ehealth applications
  - T2: an inquiry on how the communication on health on the digital media impacts on individuals' freedom of choice and can generate self-deception mechanisms
  - T3: an inquiry on the economic and social impact and consequences of the technological innovation in e-health that should orient AI and machine learning

as well as expertise of potential supervisors from Host Institutions. List of supervisors can be found at:

The match with topics indicated above and the expertise of potential supervisor must be documented through, i.a. publications, presentations at international conferences and other activities, according to the Application form.

- one-page proposal covers at least one of three cross-cutting interdisciplinary topics as well as expertise of potential supervisors from Host Institutions.

The one page proposal must include the explanation how the research proposal is matched to the cost-cutting topic/topics and expertise of chosen supervisor.

- 2. A precondition for qualification for the fellowship programme is fluency in English, at least at level B2, documented by an appropriate document which provides such information.
- 3. The candidate is aware of the responsibility, including criminal responsibility, under Article 297 § 1 of the Penal Code, for making false statements on the basis of which he/she was qualified to participate in the project.

#### § 4 [Selection procedure]

- 1. Selection will be conducted in compliance with the principle of equal opportunities and nondiscrimination, including accessibility for persons with disabilities and the principle of equal opportunities for women, men and non-binary.
- 2. The number of women qualified for the programme cannot be less than 40% of all Fellows.
- 3. The Selection Committee will ensure that people with disabilities can participate in the project.
- 4. Depending on the type of disability, a reasonable accommodation mechanism will be put in place to ensure that people with disabilities can participate in the project and/or non-discriminatory conditions of participation will be guaranteed.
- 5. Recruitment is open and will be conducted between 31.01-03.03.2022 (3:15 pm).
- 6. Candidates are obliged to submit the following documents:
  - a) Declaration of the Project Participant provided in Attachment no. 1;
  - b) Application Form provided in Attachment no. 2;
  - c) CV's in the form provided in Attachment no. 3;
  - d) One-page Proposal provided in Attachment no. 4: description of the research to be conducted including the objectives, expected scientific results, the inter/multidisciplinary aspects of the action, the gender dimension in the research content, an explanation how the project idea is relevant to the cross-cutting topics and expertise of the Host Institution and superviso;
  - e) Letter of acceptance signed by official supervisor/promotor/dean at UMCS, provided in Attachment no. 5.
- 7. The application documents should be filled in legibly, signed and delivered to the International Cooperation Centre in printed version, Rectorate, room 1207, by the deadline specified in § 4 point 5.

- 8. All application documents for the project are available on the project website and in the announcement available on: www.umcs.pl/pl/aktualnosci,21234,1.lhtm.
- 9. For the purpose of the recruitment process, a **Selection Committee** for the project will consist of representatives of the scientific Partners of REINITIALISE project.
- 10. The selection procedure comprises the following stages:
  - a) analysis of the submitted application forms and verification of the formal criteria, in particular the candidate's possession of the status of Early Stage Researcher (information will be confirmed with PhD supervisors, Heads of PhD Schools or equivalent);
  - b) qualifying participants for particular forms of support and drawing up a basic list of Fellows.
  - c) informing those qualified and those on the reserve list of the outcome of the recruitment,
- 11. If there are more applicants than available places, recruitment will be based on the following criteria:

#### a) Evaluation of scientific achievements: 30 pts:

- **15 pts**: completion of research projects/work- connected to the cross-cutting interdisciplinary topics indicated in §3 point 1.;
- **15 pts**: publications in journals, monographs or chapters/articles in monographs and conference publications- scoring within the Ministry of Education and Science list- connected to the cross-cutting interdisciplinary topics indicated in §3 point 1;

#### b) Evaluation of one-page proposal: 70 pts:

- 10 pts: the objectives,
- 10 pts: expected scientific results,
- **10 pts:** research methodology,
- 10 pts: the inter/multidisciplinary aspects of the action,
- 10 pts: the gender dimension in the research content,
- **20 pts:** an explanation how the project idea is relevant to the cross-cutting topics and expertise of the Host Institution and supervisor

In case of an equal number of points - the gender threshold and the order of application will be taken into account.

- 12. In case of not enough women's applications within this call\*, the second round will be announced with a period of submitting proposals for 14 days following the day of announcment. In case of recurring situation, the next round will be announced.
- 13. The Project Team will inform the Candidates about their qualification for the programme via email or telephone in 7 days after the closing date of recruitment process.
- 14. Persons qualified for the project are obliged to immediately sign the following documents and submit them to the International Cooperation Centre, room 1207, Rectorate (Maria Curie-
  - Skłodowska Square 5):
  - a) the scope of personal data entrusted for processing in the project,
  - b) letter of assignment with attachments.
  - 15. Failure to sign the above-mentioned documents is tantamount to resignation from participation in the Programme.

- \* Due to the REINITIALISE project, the gender balance must be ensured. At least 40% of women will be selected to the mobility programme of ESRs.
- 16. Signing of the documents mentioned in paragraph 13 of this section will take place before the start of the mobility. Documents indicated above will be provided to Fellows via e-mail.
- 17. In case of a larger number of candidates, a reserve list will be created according to the methodology of the basic list. Reserve list will be created from among Candidates meeting the conditions of participation in the Programme, who due to exhaustion of the limit of places did not qualify to participate in the project. Persons from the reserve list may be qualified to the project in case of resignation of persons from the basic list before the beginning of the Mobility Programme.
- 18. The decision on including a Candidate from the reserve list in the project is taken by the Selection Committee.

#### § 5 [Principles of project monitoring and evaluation]

- 1. Ongoing monitoring of activities planned in the project schedule is carried out as part of the project implementation.
- 2. Fellow is obliged to cooperate with the Project Team in all activities undertaken for the purpose of monitoring project implementation.
- 3. Fellow is required to participate in surveys and follow-up tests on the activities carried out in the fellowship programme.
- 4. Fellow for the purposes of project monitoring is obliged to:
  - a) inform about any changes in the data of the project participant given in the recruitment documentation, especially contact details, within 7 days of their occurrence,
  - b) confirm the support received with their own signature (e.g. attendance register).
- 5. The information referred to in points 1-4 will be used for the project reporting obligations towards the European Commission.
- 6. Fellow declares that all data contained in the recruitment documents are true and up-to-date.

#### § 6 [Responsibilities of the Fellows]

- 7. The Fellow undertakes to participate in all activities planned in the Mobility Programme:
  - a) to conduct research activities indicated in the project idea submitted in one-page proposal;
  - b) to prepare 1 paper co-authored by researchers from Host Institutions. This work will be presented at prestigious conferences or submitted as articles in international journals in open access. The fees for participation in conferences or fees for open access publications will be covered by the Project, at least by the end of the project implementation period, which is 31.12.2023;
  - c) to organize series of at least 2 lectures for colleagues from UMCS in order to present their experience gained in Host Institutions, at least by the end of the project implementation period, which is 31.12.2023;
  - d) to post at least 2 posts in English documenting the stay at the Host institution on the project Facebook account available at the following address: https://www.facebook.com/Reinitialise

- e) to shoot a small video (up to 1 minute, also by using a mobile phone) telling about his/her experience during the Programme, which will be shared through the project website/social accounts
- f) to participate in a whole 5-day Intensive Training Course workshops taking place between 7-18.03.2022 at Maria Curie-Skłodowska University. The project team will inform the Fellow by e-mail about the details and the programme.
- g) to register and use on the Knowledge Platform for further exchange of knowledge and experience with the partner institution: www.reinitialise.eu/kp/.

#### § 7 [Resignation or exclusion of a project participant]

- 1. Fellow may resign from participation in the Programme by submitting a written resignation from participation in the Programme as a result of important fortuitous events concerning his/her person which make further participation in the project impossible.
- 2. The Coordinator may withdraw a Fellow from the project in the following cases:
  - a) infringement by the Fellow of the provisions of these Call,
  - b) gross violation of the organisational arrangements for taking the fellowship,
  - c) providing false data in the recruitment documents.
- 3. If the Fellow is removed from the project for the reasons set out in point. 2 of this section, the Fellow may be obliged to reimburse the Coordinator for the costs incurred in connection with the Fellow's participation in the Project up to the date of his/her deletion from the list of participants. The final decision on reimbursement of the costs incurred will be taken individually, on the basis of the circumstances.
- 4. In case of restrictions caused by COVID-19 pandemia, the Coordinator has a right to postpone, cancel or change the form of mobility for online/hybrid form. Fellow has to be informed by Coordinator about the change at least 7 days before start of the mobility.

## § 8 [Responsibilities of the Coordinator and Host Institution]

- 1. The Coordinator undertakes to, in particular:
  - a) inform the Fellow, prior to the commencement of participation in the Programme, that it is carried out within the project co-financed by the European Union under Horizon 2020.
  - b) not to charge the Fellow any fees related to participation in the project throughout its duration.
  - c) Funding of travel costs up to a limit of EUR 400 and subsistence costs of up to EUR 45 per day for the duration of the fellowship, as well as participation in conference/open access publication with regards to disseminate joint publication with Host Institution. All costs must be agreed prior with the Coordinator of the project.
  - d) Supervise the Fellow before, during and after their return from the fellowship.
- 2. The Coordinator reserves the right not to continue the Programme in case of an insoluble obstacle to the implementation of the Project Agreement constituting the basis for its funding.
- 3. The Host Institution undertakes to, in particular:
  - a) plan, together with Fellow the mobility;
  - b) ensure, that the Fellow is provided with a support of supervisor from the Institution;
  - c) supervise the Fellow during and after their return from the fellowship.
  - d) prepare 1 paper co-authored by Fellow. This work will be presented at prestigious conferences or submitted as articles in international journals in open access. The fees for participation in

conferences or fees for open access publications will be covered by the Project, at least by the end of the project implementation period, which is 31.12.2023.

#### § 9 [Final provisions]

- 1. The Regulations enter into force on 28.01.2022 and are valid until the end of the Project.
- 2. The Coordinator reserves the right to amend the Regulations.
- 3. Fellow confirms in writing that he/she has read the Regulations and respects them.
- 4. The regulations are available on the project website and in the announcement.
