

Terms and conditions

Absolutoria 2023

Uniwersytetu Marii Curie – Skłodowskiej w Lublinie

Organiser:

1. The organiser of the series of events Absolutoria 2023 is the Maria Curie-Skłodowska University in Lublin.

General matters:

1. Each event will last a minimum of 60 minutes.
2. The event will include, among others.
 - a. Speech by the Rector's and Dean's authorities,
 - b. Speech by a representative of the student government,
 - c. Ceremonial presentation of a symbolic diploma to each of the participants in the event (the graduation diploma will be issued by the Dean's Office in accordance with the study regulations)
3. The student is required to attend the event in formal attire.
4. The organiser will provide, among others:
 - a. the ceremonial nature of the event,
 - b. the musical setting of the event,
 - c. a biretta for each participant of the event,
 - d. a glass of champagne for each participant of the event,
 - e. online broadcast of each event,
 - f. extensive photo coverage of each event,
 - g. commemorative diploma,
 - h. flowers for the rector, deans and academic staff present at the event,
 - i. each participant of the event a toga (on loan).
5. The following will also be available to participants of the event:
 - a. a commemorative monidade of the UMCS,
 - b. a media wall,
 - c. photo mirror,
6. All information will be published on an ongoing basis on www.umcs.pl/absolwent and the on occasional events on FB.

Participants

1. The event is open to UMCS students who:
 - a. have defended their thesis (first-cycle studies, second-cycle studies) after 01 January 2023,
 - b. are scheduled to defend their diploma thesis (first-cycle studies, second-cycle studies) in June, July, August and September 2023.

Enrolment:

1. Enrolment shall only take place via the online form located at www.umcs.pl/absolwent and last from 09 May 2023 to 11 June 2023.
2. Persons who do not register by the deadline or whose registration application will be incomplete or erroneously completed will not be admitted to the event.

Cost of participation:

1. The cost of participation in the event is PLN 100 gross. Payment must be made by bank transfer no later than on the day of registration and confirmation of the transfer must be included in the registration process.
