



## **RESOLUTION**

**No. XXV – 25.2/23**

**of the Senate**

**of Maria Curie-Skłodowska University**

**in Lublin**

**of 26 April 2023**

***amending Resolution No. XXIV – 26.5/19 of the Senate of  
Maria Curie-Skłodowska University in Lublin of 24 April  
2019 on the Study Regulations***

Pursuant to Article 28 sec. 1 item 2 of the Act of 20 July 2018 “Law in higher education and science” (Journal of Laws 2023 item 742) The Senate of Maria Curie-Skłodowska University in Lublin orders as follows:

### **§ 1**

In the Study Regulations, attached to Resolution No. XXIV – 26.5/19 of the Senate of Maria Curie-Skłodowska University in Lublin of 24 April 2019 *on the Study Regulations* the following amendments shall be introduced:

- 1) in § 7a sec. 2 a comma is inserted after the word “classes” and the phrase “and internships specified in the plan and programme of studies” is replaced by the phrase „including work practice, hereinafter referred to as internship, if provided for in the programme of study”.
- 2) in § 9 sec. 5 a comma is inserted after the word “classes” and the phrase “and internships specified in the plan of study and programme of teaching” is replaced by the phrase “including internships if provided for in the programme of study,”.
- 3) in § 19:
  - a) in sec. 2a, after the word “practice” the word “work” is deleted;
  - b) in sec. 4 after the word “credit”, the phrase “the documented professional work or other activities performed by the student for the account of the internship, if the learning outcomes provided for that internship in the programme of study have been achieved” is replaced by the phrase “the activities performed by the student, in particular as a part of employment, apprenticeship or voluntary service for the account of the internship, if they enabled the achievement of learning outcomes specified in the study programme for internships”.

c) after sec. 4, sec. 4a is added as follows:

“4a. The conditions and methods of documenting the activities referred to in sec. 4 are defined by the Dean’s Council and stated in the guidelines for a given Faculty or the programme of study.

4) in § 26 sec. 3a is added as follows:

“3a. The condition for passing a seminar or a diploma course in the last semester of the first/second or long cycle programme is to enter a diploma thesis approved by the supervisor into APD system, if provided for in the programme of study, and receive a positive mark for the thesis”.

5) in § 33 sec. 3 the phrase “students removed from the list of students” is replaced by the phrase „persons removed from the list of students”.

6) in § 34 sec. 2b is added as follows:

“2b. The diploma thesis supervisor, with the consent and on detailed terms established by the Dean's Council, may be supported by another person, provided that it does not lead to the increase in the number of teaching hours related to the completion of the diploma thesis”.
