

**Regulations for participation in the 5th Scientific Conference from the series
"Alternative investments"**

**I.
GENERAL**

1. The organizer of the 5th Scientific Conference from the series "Alternative investments" (hereinafter: IA 2024) is the Department of Insurance and Investments at the Institute of Economics and Finance of the Faculty of Economics of the Maria Curie-Skłodowska University in Lublin, based in Lublin, Pl. M. Curie-Skłodowskiej 5, 20-031 Lublin (hereinafter: Organizer).
2. An event participant may be an entity, natural or legal person who meets all the elements included in part II of the Conference Regulations, points 2 and 3 (hereinafter referred to as the participant).
3. The aim of IA 2024 is to exchange thoughts and experiences from research on the development of alternative investments and to present the latest results of own research in this area.
4. The conference is scheduled for October 17 and 18, 2024, with the possibility of changes referred to in points II.5 and IV.1.
5. The provisions of these regulations constitute an integral part of the application to participate in IA 2024 and apply to all its participants.
6. Registration for IA 2024 takes place by sending an application via the form on the website Inwestycje Alternatywne 2024 - application form operated by the Organizer and is tantamount to the participant's acceptance of these regulations and is a form of concluding obligations between the parties.

**II.
CONDITIONS OF PARTICIPATION AND RESIGNATION FROM PARTICIPATION
IN THE CONFERENCE**

1. IA 2024 will be held in hybrid mode. Remote participation entitles you to participate in plenary sessions, panel sessions and working sessions conducted online.
2. IA 2024 is a closed event in which only people approved by the Organizer after prior registration can participate.
3. IA 2024 is a free event for participants.
4. The languages of IA 2024 are: Polish and English, as specified by the Organizer
5. in the program which sessions or speeches will be held in Polish and which in English. The speeches will not be translated.
6. If you wish to submit a conference speech, the participant sends the application form via the Inwestycje Alternatywne 2024 platform:
 - A. by August 31, 2024, abstract according to the scheme indicated by the Organizer,
 - B. by September 30, 2024, the full text of the scientific study intended for publication,
 - C. in exceptional cases, the Organizer may accept applications after the deadlines specified in point 5.A or 5.B.
7. The organizer will immediately inform you via a message posted on the IA 2024 website if the number of entries exceeds organizational capacity. In such a situation, the Organizer reserves the right to suspend further registration of applications.
8. The organizer reserves the right not to accept the submitted presentation, in particular when its subject matter differs from that of IA 2024 or when the content of the submitted abstract does not guarantee the expected scientific level.

9. The organizer does not guarantee the publication of the full version of the submitted scientific text, but will provide participants with the following publication opportunities:
 - A. The participant may submit a scientific text (in Polish or English) for publication as part of a scientific monograph to be published by the UMCS Publishing House in Lublin (1st level publishing house). The text will be subject to review and a full editorial process. Publication in the monograph is free of charge.
 - B. The participant may submit a scientific text for publication in:
 - Special Issue *Annales Universitatis Mariae Curie-Skłodowska*, sectio H – *Oeconomia* (70 points according to the list of the Minister of Science for 2024) after meeting the standard requirements set by this journal (after obtaining two positive reviews, i.e. 2 blind reviews and paying a fee by the participant publication in the amount of approx. PLN 700),
 - *Journal of Economics and Management* (40 points according to the list of the Minister of Science for 2024) after meeting the standard requirements set by this journal (after obtaining two positive reviews, i.e. 2 blind reviews, the publication is free of charge),
 - *Folia Oeconomica (Acta Universitatis Lodzianensis)* (40 points according to the list of the Minister of Science for 2024) after meeting the standard requirements set by this journal (after obtaining two positive reviews, i.e. 2 blind reviews and the participant paying a publication fee of approx. PLN 200 PLN + 23% VAT).
10. The participant will receive a certificate of participation after IA 2024 via e-mail.
11. The organizer will make every effort to ensure that a detailed conference program is sent to participants and posted on the event website approximately one week before the conference.
12. If a participant decides to resign from participation in IA 2024, he or she should inform the Organizer about this fact by sending information to the Organizer's e-mail address: investment.alternatyw@umcs.pl with the note "Resignation from participation in IA 2024".
13. The participant acknowledges that the Organizer may record the course of IA 2024 using sound and image recording devices. The Organizer has the right to provide recorded recordings or fragments thereof to selected media partners of the event for use by them for information purposes.
14. The participant declares that he consents to the recording and dissemination of his image via the IA 2024 conference website and other websites and social media of the Organizer used to provide information about IA 2024 or the next conference being its continuation.
15. The participant acknowledges that he will receive information regarding IA 2024 by e-mail, including information regarding subsequent editions of IA, if any are organized.

III.

PROTECTION OF PERSONAL DATA

1. The administrator of personal data of participants of the IA 2024 conference is the Maria Curie-Skłodowska University (UMCS), based in Lublin, at Pl. Marii Curie-Skłodowskiej 5, 20-031 Lublin. Personal data (in accordance with the application form) are provided voluntarily, however, without providing them, participation in the Conference is not possible. They are collected by UMCS solely for the purpose of processing them during the implementation of the Conference and will be processed on the basis of:
 - art. 6 section 1 letter b GDPR - processing is necessary for the performance of a contract to which the data subject is a party or to take action at the request of the data subject before concluding the contract,
 - art. 6 section 1 letter c GDPR - processing is necessary to fulfill the legal obligation imposed on the administrator (the Law on Higher Education and Science, the implementing regulations to the Act, as well as the provisions of accounting and tax law);

- art. 6 section 1 letter e GDPR - processing is necessary to perform a task carried out in the public interest, to the extent necessary to ensure the development of science and innovation of the economy;
 - Moreover, if it is applicable indicated in the application, personal data may be processed pursuant to Art. 6 section 1 letter a GDPR, i.e. based on your consent to processing.
2. The data will not be subject to further processing or profiling, and no automated decisions will be made based on it. In justified cases, data may be made available to external recipients. The data will not be transferred to third countries and international organizations. Your data will be stored for the period necessary to achieve the purposes specified above. The personal data administrator has appointed a person supervising the correctness of personal data processing, who can be contacted at iod@mail.umcs.pl.
 3. You have the right to:
 - access to data and receiving a copy thereof;
 - rectification (correction) of your personal data;
 - restrictions on the processing of personal data;
 - deletion of personal data (subject to Article 17(3) of the GDPR);
 - withdrawal of consent to data processing, if given;
 - submit a complaint to the President of the Office of Data Protection if you believe that the processing of personal data violates the provisions of the law regarding the protection of personal data.
 4. Consent expressed pursuant to Art. 6 section 1 letter a GDPR may be withdrawn at any time, however, the withdrawal of consent does not affect the lawfulness of the processing carried out on the basis of consent before its withdrawal.

FINAL PROVISIONS

1. The Organizer reserves the right to change the IA 2024 program consisting of changing the time of speeches and lecturers. The Organizer shall not be liable for any damage incurred by the participant or the entity submitting the participant in connection with the changes referred to in the previous sentence.
2. These regulations shall apply from their publication on the IA 2024 website. The Organizer reserves the right to change the regulations at any time, with the reservation that the changes made are effective from the moment they are made public. The version of the regulations from the date of registration of the participant is binding.
