The monograph materials are accepted in **Ukrainian** or **English** and will be printed in the author's edition. **The authors are responsible for the academic integrity of the materials submitted, as well as for the accuracy of the facts and references provided.** The materials for one section (the scientific reports) should total **10-12 pages of A4 format, including the list of references.**

The deadline to submit your application and scientific report for the First International Financial Forum is **April 30, 2024.**

After receiving positive peer reviews, the high-quality papers, written in English, will be published in the scientific journal *Advanced Computer Information Technologies*, indexed in the **Scopus** scientometric database.

## SCIENTIFIC REPORTS ARRANGEMENT REQUIREMENTS:

Page and text parameters: Program: MS Word (format: .doc or .docx); Page format: A4; Margins: 2 cm on all sides; Font: Times New Roman; characters: point 14 pt size; Line spacing: 1.5; Paragraph indentation: 1.25 cm; Alignment: Justified. Pages are not numbered.

### Scientific Report (subsection) Structure:

1. Author's name and surname (the number of co-authors should not exceed five people).
2. Academic degree, academic title, position, place of work, city (postgraduate students are allowed to publish materials only in co-authorship with a supervisor).
3. Report title (in capital letters in the center of the page).
4. The main content (placed along the width of the page) with a logical introduction, main body, and conclusions. The text should not contain word breaks and macros. Graphic material

should be submitted in programs available for further editing. For figures and tables, use Times New Roman, 12 pt font, line spacing – 1, black and white (preferably). Each element of the illustrative material (table, figure) must have a title. Titles of tables and figures should be in bold. Mathematical formulas must be numbered in parentheses. Only the Microsoft Equation or Mathtype formula editor should be used to type formulas. Figures should be grouped; abbreviations and acronyms should be deciphered at the first use.

5. References (prepared in accordance with SSU 8302:2015; placed in alphabetical order; references to sources in the text are given in square brackets, for example: [2, p. 24]).

If there are appendices to a subsection, a reference to them is required in the main text. Appendices are not included in the main content of subsections. Appendices should be indicated by consecutive capital letters of the Ukrainian alphabet, except for the letters Г, Є, З, І, Ї, О, Ч, Ђ.
