At the Welcome Center, we help scholars from abroad with formalities that must be met before and after your arrival in Poland. We know that formal issues can be challenging, which is why we have prepared a checklist to help streamline all the required steps that must be completed by international visitors. The Welcome Center for Foreign Academics can provide support with respect to these matters.

Checklist

Before arrival

- set a specific date for your arrival and starting work at UMCS;
- ask your UMCS supervisor to prepare an official invitation stating the purpose of your visit, the planned duration of your stay at the University and confirmation that you have the financial means to cover the costs of your stay and your return journey;
- sign an agreement on foreigner admission for academic research and development with UMCS;

- if necessary, apply for a visa for yourself and your family members if they are coming with you (more on visas on page 13);
- acquire health insurance or travel medical insurance with a minimum coverage of EUR 30,000 for yourself and your family members (if they are coming with you);
- find accommodation. If you will be applying for a visa, you will need to show proof of accommodation in Poland. Check here how to use the accommodation available at UMCS: [UMCS DORMITORIES](#).

After arrival

- register at Lublin City Hall;
- sign a contract to rent a flat or a room in a UMCS dormitory (if you have not already done so);
- open a bank account in PLN (optional);
- sign an employment / civil law contract (if applicable);
- go to the academic unit you have come to (faculty, institute, sub-faculty, department, or meet with a specific UMCS researcher);
- ensure access to the necessary electronic means of communication (Eduroam network¹, USOS,² etc.);
- obtain information on potential tax liabilities, health contributions and pension rights that may arise from your employment status (if applicable).

Important documents

Non-EU nationals crossing the border must have:

- a valid travel document (passport or equivalent identity document) for themselves and any accompanying family members;
- a valid visa or other document authorising entry into and residence on the territory of Poland;

¹ The aim of Eduroam is to provide employees and students of educational and research institutions with access to secure communication within the scientific community. Any staff member or student registered at their home research institution participating in the Eduroam project can access the Internet at any participating institution worldwide. It uses the same credentials and access methods as the home institution.

² The University Student Support System (USOS) is a Dean's Office system that provides comprehensive support for the course of studies, students and doctoral candidates and the research and teaching staff.

- proof of health insurance. You must have health insurance for the entire period of your stay in Poland. If you have not already secured long-term health insurance in your home country, purchase travel health insurance, which is valid until you have obtained Polish insurance;
- an official invitation from Maria Curie-Skłodowska University, a document that confirms the granting of a scholarship or an agreement for the admission of an international visitor;
- a proof of sufficient financial means to cover the costs of your stay and return journey to your country of origin/residence, or explanation regarding the way of securing the means for your stay in Poland (e.g. bank statement, scholarship, employment contract).

Other documents that may be useful

- certified true copies of the doctoral diploma or any other academic title (preferably also with a certified translation into Polish)³;

³ Nostrification of education diplomas is also required. The nostrification requirement applies to diplomas awarded in countries that have not signed a bilateral agreement with Poland on recognition of education obtained abroad as equivalent to education obtained in Poland.

- biometric⁴ passport photo, e.g. for a temporary residence permit, and possibly additional passport photos for various identity documents that will be needed during your stay. Photos can also be taken in Lublin;
- information on past or current illnesses and regularly taken medication;
- international driving licence (if you intend to drive in Poland);
- child's birth certificate (if you are travelling with children);
- marriage certificate (if you are travelling with your spouse).

At the end of your stay in Poland

Before planning to return to your country, there are a few things you should pay attention to:

- if you have registered for temporary residence at the Lublin City Hall, you will be automatically de-registered after the expiry of the registration period;
- remember to terminate your accommodation contract and comply with the formalities with regard to leaving your room, if you were accommodated in a UMCS dormitory;
- if you opened a bank account, go to the bank branch to close the account;
- make sure you obtain the documents you are obligated to submit to the institution financing your stay in Poland in order to settle it;
- notify the UMCS International Cooperation Center about your departure.

⁴ A biometric photograph facilitates verification of identity at checkpoints. The scanned document (e.g. at the airport) is checked by computer software which compares the image with the photo stored in the microchip. Identity verification is based on a precise comparison of biometric features, such as the size and shape of the nose and mouth, the spacing of the eyes or the position of the cheekbones. Confirmation of identity is possible even if the holder of the document changes his/her image, i.e. grows his/her hair or shaves his/her beard.

COMING TO POLAND – STEP BY STEP

■ Visa

You may need a visa to enter Poland and, in the event of a longer stay, a residence permit and temporary residence registration.

- ① *Visas are issued to foreigners coming to Poland as Schengen visas or national visas by a Polish consul. To obtain a visa, you must apply to the appropriate Polish diplomatic or consular post.*

A Schengen visa (marked with the C symbol) – is issued when the planned stay in the territory of the Schengen Member States¹ does not exceed 90 days within each 180-day period.

A national visa (i.e. long-term visa – marked with the D symbol) – entitles its holder to enter the territory of the Republic of Poland and in a single continuous period in that territory or over several consecutive stays lasting more than 90 days in total; the period of validity of a national visa cannot exceed one year.

The addresses of Polish diplomatic and consular missions abroad are available on the website of the Ministry of Foreign Affairs [POLAND'S MISSIONS ABROAD – MINISTRY OF FOREIGN AFFAIRS REPUBLIC OF POLAND – GOV.PL WEBSITE \(GOV.PL\)](#).

We recommend consulting the website of the relevant consulate as a definitive source of information, as the rules related to the foreigner's visa application may vary from country to country.

¹ The Schengen Area is a territory with guaranteed freedom of movement of persons. The Schengen Area does not cover all the territory of the European Union. The Schengen Area includes: Austria, Belgium, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, as well as Norway, Iceland, Liechtenstein and Switzerland. Cyprus, Bulgaria, Ireland, Romania, the United Kingdom and Croatia are not members of the Schengen area.

Citizens of certain countries are entitled to stay under the visa-free regime. Check the website of the Office for Foreigners to see if your country is listed there: [DO I NEED A VISA | OFFICE FOR FOREIGNERS \(UDSC.GOV.PL\)](#).

If you have crossed the border under the visa-free regime and your stay in Lublin/Poland will exceed 3 months, you should go to the Lublin Voivodeship Office (4 Spokojna Street, 20-914 Lublin). The procedure to legalise your stay is simple and free of charge. The application must be submitted in person no later than one day after the expiry of the period of three months from the date of entry into Poland. The document confirming registration is a written declaration.

Registration obligation for foreigners in Poland

All foreigners are required to register their long-term residence in Poland. This obligation applies both to citizens of the Member States of the European Union and all other persons arriving from abroad.

Upon arrival in Lublin, register at the Lublin City Hall

- no later than 30 days from the day of your arrival in Poland if your stay in Poland is going to exceed 3 months and you are a citizen of a European Union (EU) member state, a citizen of a European Free Trade Association (EFTA) member state or his/her family member;
- no later than on the 4th day from the day of your arrival at your place of temporary residence in Poland if you will be staying in Poland for more than 30 days and you are not included in the above group.

The registration service is free of charge. A certificate of temporary residence is issued at the request of the foreigner and is subject to an administrative fee (PLN 17). Foreigners registering for temporary residence in Poland for the first time will also receive a PESEL (Personal ID) number.

Practical tip: if you want to avoid queues at the office, try to go to the office on a Wednesday or Thursday. The busiest days are Monday and Friday.

Registration of residence for citizens of the European Union/EEA and Switzerland

EU citizens and their family members who are not EU citizens may stay in Poland for up to 3 months without fulfilling any residence conditions other than holding a valid travel document. A citizen of the EU may hold another valid document proving his/her identity and nationality.

In the event of a stay in the territory of the Republic of Poland for more than 3 months, an EU citizen and his/her family members holding EU citizenship are obligated to register their stay, and a family member who is not an EU citizen is obligated to obtain a residence card of the EU citizen's family member.

The obligation to register residence does not apply to an EU citizen who has the right of residence in order to seek work.

An application for registration of residence should be submitted in person to the Lublin Voivodship Office no later than on the day following the expiry of 3 months from the date of entry into the territory of Poland. The requirement to submit the application in person does not apply to a minor.

NOTE

The obligation to register the residence of an EU citizen is not the same as the obligation to register in Poland. The authority competent to register the residence of an EU citizen is the governor competent for the place of his/her residence. However, the competent authority with respect to the registration obligation is the relevant municipality authority (municipality administrator or mayor).

To register the residence of EU citizens (including their family members who are also EU citizens) and to obtain a residence card for an EU citizen's family member, EU citizens must fulfil the conditions of the right of residence exceeding 3 months.

EU citizens have the right of residence exceeding 3 months if they meet one of the following conditions:

- they are an employee or self-employed person in the territory of the Republic of Poland;
- they have the sufficient financial means to support themselves and their family members on the territory of the Republic of Poland so as not to become a burden on social assistance, and have suitable health insurance;
- they are studying or undergoing vocational training in the Republic of Poland and: a) have the sufficient financial means to support themselves and their family members on the territory of the Republic of Poland so as not to become a burden on social assistance, and have suitable health insurance; b) are married to a Polish citizen.

Required documents

- a completed European Union citizen right of residence application form;
- a valid travel document or other valid proof of identity and citizenship (original to be presented for inspection);

NOTE

If the foreigner does not have any of the above-mentioned documents, they will be required to provide them within 7 days from the delivery of the summons or the application will not be considered further.

- a certificate of registration of residence of a European Union citizen issued to a citizen of the European Union with whom a family member resides in the territory of the Republic of Poland;

other required documents

- in the case of an employee – a written declaration of an employer or an entity authorised to employ the European

- Union citizen on the intention to employ the individual or a certificate of employment;
- in the case of a self-employed person in the territory of Poland – a written declaration concerning the entry in the National Court Register or in the Central Register and Information on Business Activity, or other proof confirming that the European Union citizen is a self-employed person in the territory of the Republic of Poland;
 - in the case of students or persons undergoing vocational training:
 - a certificate from a state-owned or private higher education institution confirming enrolment at a university or referral to vocational training;
 - a document confirming coverage by general health insurance or entitlement to healthcare services based on regulations relating to the coordination of social security systems, or possession of private health insurance;
 - a written statement that confirms possession of sufficient financial resources to support oneself and family members in order not to be a burden on social assistance, or proof of possession of such resources;
 - in the case of a spouse of a Polish citizen – a document confirming marriage to a Polish citizen;
 - in other cases:
 - a document confirming coverage by statutory health insurance or entitlement to healthcare under the provisions on the coordination of social security schemes, or possession of private health insurance;
 - proof of possession of sufficient financial means to provide for oneself and family members so as not to become a burden on social assistance.

NOTE

Proof that you have the sufficient financial resources to support yourself and family members so as not to become a burden on social assistance may include, in particular:

a credit card proof of sufficient funds held at a bank or other financial institution, certified by the stamp and signature of an authorised officer of that bank or institution, issued not later than one month prior to submission of the application for registration of residence.

NOTE

If there is a need to clarify or specify the proof held by the authority with regard to the case during the proceedings, the foreigner may be called upon to provide additional documents or to give testimony confirming the circumstances referred to in the application.

Required fees

There is no charge for registering residence and issuing a certificate of registration of residence of an EU citizen. The administrative fee for submitting a declaration of power of attorney is PLN 17.

Processing time

Registration of residence and residence registration certificate of an EU citizen should be applied for without delay.

Information about the document to be issued

An EU citizen whose residence has been registered should be issued an EU citizen residence registration certificate. A valid travel document should be presented when collecting the EU citizen residence certificate, and if it collected by an applicant's proxy – the power of attorney for collecting the certificate should also be presented. EU citizens may present another valid document proving their identity and nationality.

Failure to comply with the obligation to register residence in the territory of the Republic of Poland is punishable by a fine.

Residence card

A residence card is a residence document issued to foreigners who have been granted in Poland:

- a temporary residence permit,
- a permanent residence permit,
- a long-term EU-resident permit,
- a residence permit for humanitarian reasons,
- international protection (refugee status or subsidiary protection granted in Poland).

During the period of its validity, a residence card confirms the identity of the foreigner during their stay in the territory of Poland and, together with the travel document, entitles them to cross the border multiple times without the need to obtain a visa. Furthermore, a residence card is a residence document which, aside from a valid Polish visa, entitles its holder to travel within the Schengen Area for a period not exceeding 90 days in any 180-day period if the foreigner:

- holds a valid travel document,
- can justify the purpose and conditions of the planned stay,
- has sufficient means of support or is able to obtain such in a lawful manner,
- is not deemed to be a threat to public order, internal security, public health or the international relations of any of the Member States, and in particular no alert for refusal of entry has been issued in Member States' national databases on this basis, and the foreigner's particulars are not listed on the national list of alerts for refusal of entry of the Member State concerned.

The Polish tax system includes several forms of taxation. It is important to remember to make timely payments and submit tax returns, since the government authorities impose penalties for tax evasion.

Health insurance

If you are insured in EU/EFTA Member States

If your stay is temporary, you can only receive necessary medical care. You will receive the following benefits on the same basis as persons insured in Poland:

- guaranteed health services,
- supply of orthopaedic appliances and aids,
- reimbursable drugs.

The National Health Fund (NFZ) will cover the cost of your treatment if you present:

- A European Health Insurance Card¹ or
- A certificate temporarily replacing the European Health Insurance Card – if you cannot ask your insurer to send you the Certificate, the service provider (e.g. a doctor or a clinic) may contact the regional branch of the NFZ. This

¹ The EHIC application procedure is regulated by the laws of each country.

branch will act as an intermediary in obtaining this document from the institution where you have health insurance.

NOTE

If you do not have a European Health Insurance Card or a Certificate, your doctor may bill you for your treatment. You can then seek reimbursement from the institution where you have health insurance.

Which healthcare services you are entitled to depends on the nature of your stay in Poland.

If you are insured in Poland

You have the same access to medical care as insured Polish citizens.

If you are a citizen of a country that has signed a treaty or a bilateral agreement with Poland

You can receive the necessary medical care if you are in Poland legally and:

- you suddenly fall ill,
- you have an accident.

In such a situation, the Ministry of Health will cover the costs of treatment.

Countries that have signed a treaty or a bilateral agreement with Poland:

- Albania,
- Bosnia and Herzegovina,
- Montenegro,
- Russian Federation,
- Republic of Macedonia,
- Serbia,
- Tunisia.

NOTE

If you are not insured in Poland or another EU/EFTA country and you are not a citizen of a country that has signed a bilateral agreement with Poland, you can pay for medical care. If you have a suitable medical insurance policy, e.g. required for a Schengen entry visa or a national visa, the provider (e.g. a doctor or clinic) will settle the costs of medical care with your insurance company.

■ Safety

Poland is a safe country and friendly to foreigners. The terrorist threat level is low. Nonetheless, you should be familiar with the emergency numbers.

LUBLIN – A CITY OF INSPIRATIONS

Lublin is often referred to as the Gateway to the East. The city is the capital of Lublin Voivodeship, one of sixteen administrative regions in Poland.

Every year, the city hosts international art events, theatre festivals, music festivals and contemporary art festivals. These concerts, exhibitions and festivals, especially in summer, fill the city streets with crowds of art lovers. The most popular cultural events include: Carnival Sztukmistrzów, Different Sounds Festival, Night of Culture, the Jagiellonian Fair, Neighbours – Central European Theatre Festival, Theatre Confrontations International Festival and the European Festival of Taste.

Lublin also stands out as a prominent academic centre. With its wide range of fields of study and highly qualified academic staff, it attracts both Polish and international students. More than 60,000 students study at public universities (Maria Curie-Skłodowska University, the John Paul II Catholic University of Lublin, the University of Life Sciences, the Medical University, the Lublin University of Technology) and private universities, with more than 6,700 foreign students from over 100 countries.

Since 2004 (when Poland joined the European Union), Lublin has made intensive use of EU funds, completing numerous public development projects. As a result, it is developing as a centre for science, culture, tourism, sport and recreation, as well as services and industry. It is also becoming a key transport hub: it has an expressway and an airport.

It is here that at the end of the 1970s, the first fibre optic cable in Poland was designed and created by the employees of Maria Curie-Skłodowska University. The Lublin fibre optics factory (also the first in Poland) was established in 1983.

It is also home to Lublin Science and Technology Park, a science and research centre that serves as a meeting place for scientific institutions and businesses. All of Lublin's universities, as well as the city and local government have been involved in the project. The aim of the meetings is joint investment in innovative technologies.


With the support of EU funds, the Lublin IT Highland project was also created. The project, implemented by the Lublin City Hall, is an initiative to highlight the potential and create a favourable environment for the development of the IT industry in Lublin, which is currently the most rapidly growing branch of the local economy. The concept of the Lublin IT Highland is based on the "triple helix" principle, consisting of the cooperation of public authorities, academic circles and businesses in order to increase the competitiveness of each entity. The project's priority is to support the local IT base in Lublin by developing mutual links in the scientific and business communities related to IT and ICT technology.

How to get to Lublin?

Lublin is approximately 170 km from Warsaw, 180 km from Rzeszow and approximately 100 km from the Ukrainian border. There are railway stations, including the Central Railway Station, and the Central Bus Station. The Lublin Airport in Świdnik operates scheduled and charter flights to the UK, the Netherlands and Norway.


 **THE LUBLIN AIRPORT** in Świdnik can be reached from the city in several ways:

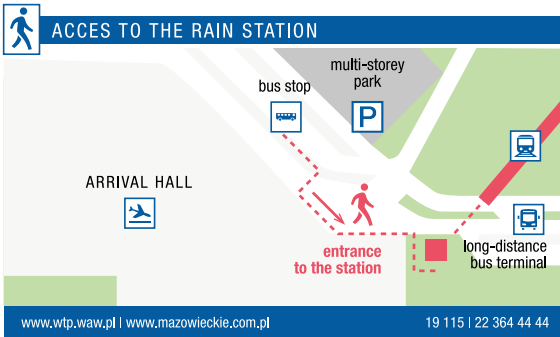
Trains from the airport arrive at the main railway stations in Warsaw. The stations: Warszawa Centralna, Warszawa Wschodnia, Warszawa Zachodnia, and Warszawa Śródmieście, allow convenient transfers to many destinations throughout Poland.

To get to Lublin by train, the most convenient way is to go to either the Warszawa Centralna or Warszawa Wschodnia railway station. BUSES AND TROLLEYBUSES

Public transport in Lublin provides service throughout the city and the metropolitan area. It consists of buses and trolleybuses (called “trajtek” by the locals), which are rarely seen in Polish cities. The municipal transport company operates several dozen daytime lines and 3 night-time lines.

Night and holiday healthcare

Night and holiday healthcare is primary healthcare provided outside the normal opening hours of outpatient clinics – Monday to Friday between 6 p.m. and 8 a.m. the following day, and 24 hours a day at weekends and other public holidays. In the event of a sudden illness or a sudden deterioration in health, a patient can go to any night and holiday healthcare centre for help, regardless of where they live.

THE DOCTOR ON DUTY GIVES ADVICE

- in an outpatient setting,
- in the patient's home (in medically justified cases),
- by phone.

You can use the services of the doctors and nurses at night and on holidays in the event of:

- sudden illness;
- a sudden deterioration of your health, when there are no symptoms suggesting an imminent threat to your life or a significant deterioration of your health, and where home remedies or over-the-counter medication have not provided the expected improvement;
- in the event that waiting for a clinic to open could significantly adversely affect your health.

Schools in Lublin

In Poland, compulsory education starts at the beginning of the school year in the calendar year in which a child turns 7 and lasts until the end of primary school or until the child turns 18. Education starts in an eight-grade primary school. Afterwards, pupils can choose to continue their education in a 4-year general secondary school, a 5-year technical secondary school or a 3-year vocational secondary school.

LUBLIN CASTLE

The Lublin Castle is one of the architectural symbols of Lublin. Its history dates back to the 12th century. It has been rebuilt many times over the centuries. During the Second World War, it served as a Gestapo detention centre. From 1944–1954, the castle housed an NKVD and Department of Security prison. Today it houses the National Museum in Lublin. Its mission is to protect the historical and artistic values of Polish and world culture, including in particular the heritage of the Eastern territories of the former Republic of Poland. You can buy tickets to see three attractions available at the Castle:

- museum exhibition (National Museum in Lublin),
- chapel of the Holy Trinity,
- castle tower with an view over the city.

ARCHCATHEDRAL OF LUBLIN

The Church of Saints John the Baptist and John the Evangelist was built in 1586–1604. The church was designed by Brother Giovanni Maria Bernardoni. In the 18th century Joseph Meyer decorated the interior of the church with paintings depicting scenes taken from the Bible. The church was made a cathedral in 1805. Destroyed during World War II, it was rebuilt in after the war. The Lublin Archcathedral is a gem of Baroque art in the Lublin region.

The church can be visited daily outside of times when services are being held.

The symbol of the site is the monument dedicated to the memory of the victims of Nazism.

OLD TOWN

Lublin's Old Town is a unique place on the map of Europe and Poland, included on the list of Polish of Historic Heritage sites. More than 70% of the buildings are original and the oldest buildings date back to the 13th century. Remarkably, the buildings have been preserved in their historic form, and there are 110 listed buildings in an area of almost 1 km². Without a doubt, every visitor will find something interesting there. The most noteworthy points on the map of the Old Town include: Krakowska and Grodzka Gates, Gothic towers, the Crown Tribunal, the Archcathedral of Lublin, the Trinity Tower, the Dominican Basilica, the Old Theatre, Po Farze Square, the Lublin Castle with the Chapel of the Holy Trinity and the Castle Tower.

UMCS BOTANICAL GARDEN

The Botanical Garden is situated in the valley of the Czechówka River. The terrain is characterised by loess hills crossed by ravines descending into ponds. On an area of 21.25 hectares, almost 7,000 species and varieties of plants from all over the world have been collected and are used for educational, teaching and scientific-research purposes by students and staff of Lublin's universities. From spring to autumn, open-air cyclical and one-off events are organised here. It is also one of the favourite places for individual recreation of Lubliners and tourists. The peculiarity of the garden is the historic Kosciuszko Manor House.

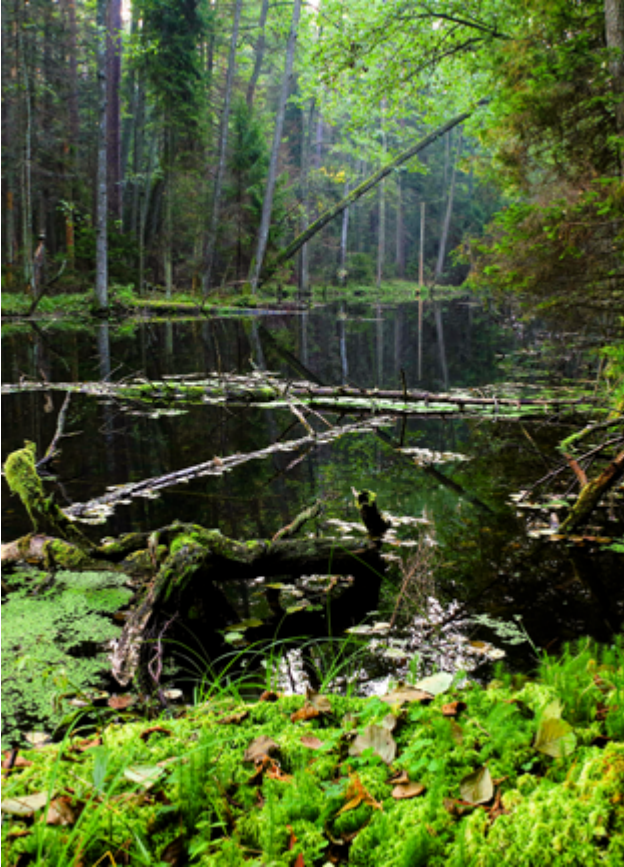

ZAMOŚĆ

The town of Zamość is called a pearl of the Renaissance. The city plan drawn by Bernard Morand refers to an anthropomorphic concept and resembles a human silhouette. The palace is the head, the main street connecting the mansion to Bastion VII is the spine, the academy and cathedral are the heart and lungs. The transverse artery with three markets is the belly, while the bastions used for defensive purposes are the arms and legs. The Old Town of Zamość was added in 1992 to the World Heritage List by UNESCO, recognising it as one of the world's finest urban complexes. In addition to the monuments of the Old Town, there is a large ZOO, a beautiful park, a modern cinema and the oldest symphony orchestra in Poland. Zamość is also an ideal base for trips to the Roztocze and Lviv.

Based on the Act of the 20th day of July 2018, Law on tertiary education and science, on April 24, 2019, the Rector of UMCS established three doctoral schools: Doctoral School of Humanities, Doctoral School of Social Sciences, and Doctoral School of Quantitative and Natural Sciences.

The School of Doctoral Sciences of Quantitative and Natural Sciences is run jointly with the Institute of Agrophysics of the Polish Academy of Sciences in Lublin, the Institute of Soil Science and Plant Cultivation in Pulawy, and Jerzy Haber Institute of Catalysis and Surface Chemistry Polish Academy of Sciences.

University-wide units

THE UMCS BURSARY OFFICE is responsible for receiving and checking financial documents for formal and accounting compliance; processing payments and generating transfer receipts; settlement of expenses for trips abroad; providing financial services for research projects (location: Rector's Office building, 8th floor);

THE UMCS HR AND PAYROLL CENTRE provides comprehensive services for employees working at the University. This is where our employment contracts are signed (location: Rector's office building, 9th floor);

THE CENTRE FOR EDUCATION AND STUDENT SERVICES is responsible for supervising and coordinating the process of education first and second-cycle courses, long-cycle studies, doctoral studies / doctoral and postgraduate schools, and continuing education courses (location: Rector's office building, 10th floor);

THE CENTRE FOR KNOWLEDGE AND TECHNOLOGY TRANSFER supports entrepreneurs in establishing cooperation with researchers from the University; it develops individually designed proposals for cooperation between entrepreneurs and the University, coordinating the implementation of commissioned studies, research and development projects for the energy, IT, medical, biotechnological, food, construction, fuel and other industries; it also looks after the protection of intellectual property, carrying out research result, patent and copyright commercialisation procedures (location: Rector's Office building, 12th floor);

THE LEGAL AND ORGANISATIONAL CENTRE is responsible for organising and coordinating work in the field of internal legislation and cooperating with subject-related units in this respect, preparing and publishing interpretations and analyses of internal regulatory acts and providing information on the interpretation of generally applicable legislation; recording, collecting and publishing legal acts issued by the Senate, the Rector, Vice-Rectors and the Chancellor (location: Rector's Office building, 13th floor);

The International Cooperation Center is a specialised unit of UMCS administration supporting international scientific cooperation at our University.

We help in finding appropriate sources of funding for research conducted in collaboration with partners in other countries, provide consultation on applications and support the implementation of international research projects.

Virtual Campus



UMCS Library

The Maria Curie-Skłodowska University Library is a centre for education, information and culture that offers its services to students and scholars and all those who interested in improving their qualifications and expanding their knowledge. The Main Library of the Maria Curie-Skłodowska University, with 16 specialist libraries, forms the University's library and information system.

At present, the Library's holdings are universal in nature and include traditional collections: books, periodicals, rare books and manuscripts, cartographic, graphic and musical collections. A very important part of the library are books and electronic journals available through licensed database resources and the Digital Library of Maria Curie-Skłodowska University. Users can use the Primo multi-search engine, which searches the electronic resources of international publishers, the resources of the Maria Curie-Skłodowska University Digital Library and the catalogue of the Maria Curie-Skłodowska University Library.

The Main Library building complex is situated in the centre of the University Campus, of which it is an integral part. The library is easily accessible to users, including those with disabilities.
