

The programme structure

CIMA's CGMA University Program is implemented through selected courses at the university. Candidates who complete all required courses are exempt from specific CGMA exams. After passing the final external exam, you can obtain a diploma at two or even three levels: Certificate, Operational or Management.

STEP Check your eligibility.

STEP Sign up for the CGMA Program.

You can join the program every year from 14 October until 30 November. Register your interest at cimauczelnie.pl. Your university coordinator and CIMA will verify your program eligibility.





STEP Become a CGMA candidate.

Register with us and pay a one-time registration fee, which includes initial registration and your first year subscription fee.

All CGMA University Program participants are full-fledged CGMA candidates with all the global and local benefits.

STEP Schedule your exams.

4

Continue your degree studies as usual. Upon passing all your university exams, you will be granted exemptions from certain exams.

Schedule your exam date and pay an exam fee. All you have to do to receive your CGMA diploma is to pass a standardized external exam.
