REGULATION OF THE MINISTER OF FAMILY AND SOCIAL POLICY ¹⁾

of 25 October 2022

amending the Regulation on the entitlements to be paid to an employee working in a state or local government unit of the budgetary sphere for a business trip

Pursuant to Article 77⁵ § 2 of the Act of 26 June 1974 – Labour Code (Journal of Laws of 2022, items 1510, 1700 and 2140), it is ordered as follows:

§ 1. The Regulation of the Minister of Labour and Social Policy of 29 January 2013 on the entitlements to be paid to an employee working in a state or local unit of the budgetary sphere for a business trip (Journal of Laws, item 167 and of 2022 item 1481) is amended as follows:

1) in § 7 subsection 1 shall be replaced by the following:

”1. The allowance during a domestic trip is intended to cover the increased cost of food and is PLN 45 per day of travel. ”;

2) the Annex to the Regulation shall be replaced by the text set out in the Annex to this Regulation.

§ 2. 1. In the case of a business trip abroad commenced and not completed before the date of entry into force the Regulation, business travel dues shall be determined:

- 1) for the duration of a trip before the date of entry into force of the Regulation – on the basis of the provisions of the Regulation amended in § 1 in the current wording;
- 2) for the duration of a trip before the date of entry into force of the Regulation – on the basis of the provisions of the Regulation amended in § 1 in the wording amended by this Regulation.

2. In the case of a domestic business trip commenced and not completed before the date of 1 January 2023, the business trip dues shall be determined:

- 1) for the duration of a trip before the date of 1 January 2023 – on the basis of provisions of the Regulation amended by § 1 in the current wording;
- 2) for the duration of a trip as of 1 January 2023 – on the basis of provisions of the Regulation amended by § 1 as amended by this Regulation.

§ 3. The Regulation shall enter into force 14 days after the date of publication, with the exception of § 1 item 1) which shall enter into force on 1 January 2023.
