Through its blend of scientific research and oratory, this event encourages critical thinking and persuasive argumentation—essential elements for shaping future professionals in the fields of law and administrative sciences. The competitive format fosters performance and creativity, with the best presentations being rewarded at the end of each day.

Having become a tradition for the Constanța School of Law and Administrative Sciences, this scientific event has enjoyed almost uninterrupted organization over the years, adapting to various formats. Since 2021, the event has expanded its horizons through collaboration with other faculties, both nationally and abroad. Participants have gained the opportunity to interact with colleagues from other academic centres, enriching their knowledge and honing their skills in a multilingual and multicultural setting.

#### Registration and participation

Any student enrolled in a bachelor's or master's degree program in **law** or **administrative sciences** at an accredited faculty in Romania or abroad is eligible to participate. Each presentation must not exceed **10 minutes**. Participants may use PowerPoint slides. Depending on the topics of the papers, the organizers may group them to encourage *panel discussions* or *Q&A sessions*. The best presentations will be awarded in each section at the end of each day.

**There is no registration fee.** Registrations are open until 30 April 2025, at 11:59 PM, and may be done by completing the form available **here**. At the time of registration, authors must submit the **title**, **abstract**, and **keywords** of their paper. The results of the peer review shall be communicated to the email address provided during registration.
