Abstract:

The main topic of the conference will be the current challenges of polycrisis on the current legal regulatory issues. The conference will be focus to the comparison the recent issues, challenges, and transformations on the legal regulation influenced by the different type of crises (climate crisis, pandemic, energy crisis, instability in the national and European political systems etc.) in the Polish and Hungarian legal systems. The conference has a multidisciplinary approach, because the different phenomena will be analyzed by political science, administrative science, sociology and even disability studies approach, as well. First of all, the impact on constitutional regulation will be reviewed by the presentations, especially the impact on fundamental rights and on the concept on legal capacity of fundamental rights. Not only the constitutional background, but several major issues of the administrative law and administrative systems will be examined by different approaches. Similarly, the impact on the private (civil) law and the sociological background of these transformation will by analysed by the presentations. Even the challenges of modern democracies will be examined, especially the issues of public participation in decision making procedures. The conference is linked to an international research project – Wtare4All Project ‘ClimEx-PE’ –, an international action project on children’s rights and public participation – CERV-24-CHILD Project ‘CLAP’ –, a Hungarian national research projects (OTKA) – OTKA K 132712 – and a COST Action – CA 20123 IGCOORD.
