announces a competition for the position of assistant professor in the group of research and teaching staff in the Department of Insurance and Investment at the Institute of Economics and Finance, Faculty of Economics, Maria Curie-Sklodowska University

The competition is open to persons who meet the conditions set out in the Law on Higher Education and Science of 20 July 2018. (i.e. Journal of Laws of 2024, item 1571, as amended) and in the Statutes of the Marie Curie University of Science and Technology of 29 May 2019, as amended.

#### I. ELIGIBILITY CRITERIA FOR THE COMPETITION:

- Possession of a doctoral degree in the social sciences in the discipline of economics and finance
- having an aptitude for research and teaching, confirmed by the opinion of an independent research and teaching staff member research and teaching staff;
- having a significant scientific output, including post-doctoral output;
- to be actively involved in scientific life;
- teaching experience in corporate finance, alternative investments including real estate, analytics of financial institutions;
- having a publication record in the discipline of economics and finance, e.g. in the areas of corporate finance, alternative investments, monetary policy (articles, chapters in monographs, monographs);
- fluency (spoken and written) in Polish and in a foreign language (preferably at least B2 English);
- experience in organisational work.

### II. THE APPLICATION FOR THE COMPETITION SHOULD INCLUDE:

- application addressed to the Rector of the University;
- a copy of the doctoral diploma;
- a personal questionnaire and a professional curriculum vitae;
- list of scientific publications;
- list of scientific, teaching and organisational achievements;
- declaration of fulfilment of the requirements, in accordance with Article 113 of the Act of 20 July 2018. *Law on Higher Education and Science* (i.e. Journal of Laws 2024, item 1571 as amended);
- a declaration by the candidate that the UMCS will be the primary place of work of a scientific and research nature;
- a declaration by the candidate that he/she agrees to the processing of personal data, in accordance with Article 6(1)(a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation);
- opinion of an independent research and teaching staff member on aptitude for research and teaching.

# **III. CONDITIONS OF EMPLOYMENT:**

- Employment under a fixed-term contract of employment from 1 October 2025 to 30 September 2026 on a full-time basis at the primary place of work.

The person entering the recruitment process is obliged to provide data to the extent resulting from Article 22 <sup>(1) of</sup>the Code of Labour and the specific regulations for the employment of the position. The provision of data to a broader extent than that resulting from the regulations is voluntary. The basis for the processing of the data is the provisions of law and consent, with regard to data beyond the scope resulting from the regulations.

Pursuant to Article 7(3) of the General Data Protection Regulation, with regard to data going beyond what is provided for by law, the data subject shall have the right to withdraw consent at any time, whereby the withdrawal of consent shall not affect the lawfulness of processing carried out on the basis of consent prior to its withdrawal.

In accordance with Articles 15 to 21 and Article 77 of the General Data Protection Regulation, the data subject has the right of access, rectification, erasure or restriction of processing and the right to object to processing and to lodge a complaint with a supervisory authority, as well as the right to data portability. The data you provide will not be processed for the purpose of automated decision-making, including profiling.
